Meeting called to order 5:00pm – Annette Perot

1. Approval amended minutes of Combined Meeting of January 12, 2011 – Annette Perot

2. Treasurer's Report – Linda Herda

3. Recommendation of Chapter Secretary – Annette Perot

4. Guest Speaker: Current SMCCCD Board of Trustee Richard Holober
Mr. Holober addressed the membership and asked for our endorsement in his bid for County Supervisor. He spoke of his qualifications, background and why he believed he should be elected. Chapter 33 members asked Mr. Holober different questions regarding his stance on various issues of importance to them. After his departure, the membership voted on whether Chapter 33 should give him our endorsement given his history of being pro-union and positive position toward classified workers. Motion to endorse Richard Holober: opposed 0, abstained 0 motion was carried by all members present.
